**Agenda** The proposed release of lands measuring 1.24 acres for the use of "**St. John's Academy, Kankarbagh, Patna**," in fulfillment of the requirements of the Central Board of Secondary Education for granting of affiliation to the School.

**Whereas** "**St. John's Academy, Kankarbagh, Patna**" was established, supported and administered by **Patna Parish Society**, a unit of the Catholic Archdiocese of Patna ,for the purpose of educating the children of the Christian Minority Community and other children of the locality, and has been fulfilling the aforesaid functions for many years.

**Whereas** The need has now been felt to petition the Central Board of Secondary Education for affiliation of the school.

**Resolved that** The lands on which the school buildings are constructed and adjoining lands, totaling an area of 1.24 acres, as listed below, and which are registered in the name of Catholic Church, Kankarbagh, be and are hereby released for the sole use of "**St. John's Academy, Kankarbagh, Patna**", for as long as the school remains and imparts education to the needy children.

- a) Land will be purchased in the name of Catholic Church.
- b) Catholic Church will be established under the guidelines and aegis of Patna Parish Society.
- c) A school will be established in the name of St. John's Academy as per CBSE norms in the above said proposed land.
- d) The said school will be affiliated to CBSE New Delhi.
